

Instructions for Obtaining Permission and Incorporating Credit Lines Marcel Dekker, Inc.

It is the author's responsibility to:

- obtain all permission to reproduce previously copyrighted material
- insert all necessary credit lines in the manuscript, *incorporating any special wording required by the copyright holder*
- pay all fees required by the original copyright holder to use the material

Marcel Dekker, Inc. assumes that every author will obtain the necessary permissions in writing and will retain those letters of permission in his or her files.

There are three categories into which material (usually figures and tables) generally falls:

Permission required: Any material being reproduced exactly, or in a slightly modified form, requires permission. This includes material you are using courtesy of a colleague, company, or corporation. Even if you are reproducing your own previously published material, you will still need to apply for permission, unless you have retained the copyright. Also, permission obtained for one edition usually needs to be requested again for a subsequent edition.

Enclosed is a Request for Permission form. To obtain permission, send the completed form to the original copyright holder—generally the publisher. (Note that if the material you wish to use has a credit line to a previous source, you need to request permission of that original source, not of the publication you found the material in.) If the publisher indicates permission is contingent upon obtaining the author's permission as well, this must be done. When you receive the signed form, retain it for your files.

Quoting copyrighted poetry or lyrics *always* requires permission, no matter how short the quotation.

Permission optional: Material loosely based on, adapted from, or compiled from data from a previously published source may require permission. Use your judgment in these cases, depending on the extent to which you are using the original material. If appropriate, use "Adapted from..." in the credit line.

Permission not required: Figures and tables based entirely on original data and not published elsewhere, or taken from U.S. Government publications and thus in the public domain, do not require permission. Figures and tables based entirely on original data and published only in the first edition of this book.

CREDIT LINES Every figure and table needs a credit line, unless it is based entirely on original data and has not been published elsewhere. Even material in the public domain should have a credit acknowledging its source. Please include credit lines in the following formats, depending on which reference system is being used in your contribution:

Figures (include at the end of the figure legend)

(From Ref. 10.)

or (From Smith, 1982.)

or (Courtesy of J. Smith, Blank Corporation, New York, New York.)

Tables (include as a footnote to table)

Source: Ref. 10.

or Source: Smith (1982).

or Source: Courtesy of J. Smith, Blank Corporation, New York, New York.

Note that it is not necessary to include "with permission." It's implicit: if you don't have the source's permission, you should not be using the material. Be sure to include any special wording (e.g., Copyright © 1990 American Heart Association) required by the publisher. If you are advised of special wording after you have submitted your manuscript, please forward it to us immediately, specifying the figure or table—as numbered in your manuscript—to which it pertains.
